Advanced Dental Therapist or Dental Therapist?

CODA received a report from the Task Force on Development of Accreditation Standards for Dental Therapy Education Programs and directed that the proposed accreditation standards be circulated until December 1, 2013 for comment from the communities of interest, Comments on the standards will be considered at the January 2014 Commission meeting. The Commission will also be soliciting comments from the communities of interest related to the program track for dental therapy. The proposed standards are presented as a nondental hygiene track, but the standards could be modified to support a dental hygiene program track. A Dental Therapist is considered a mid-level provider between that of a dental assistant or dental hygienist and a dentist.

Minnesota was the first state to adopt the Dental Therapy mid-level provider model but they did not originate the concept. It was a model created by the American Dental Hygiene Association and they named it the Advanced Dental Hygiene Practitioner (ADHP).

Minnesota divided it into two levels:

Advanced Dental Therapist (ADT)

The same concept as the ADHA's ADHP, the ADT graduates earn a master's degree and it is a dental hygiene track whereby graduates of an ADA accredited program who earn a bachelors degree are qualified for the ADT Master's Degree program. This program is currently offered by Metropolitan State University.

Please note that in the list of duties of a DT in the MN Dental Board link there is no mention of "dental prophylaxis" in the DT scope of practice, yet in the proposal of the standards sent forth to CODA the following list of duties is indicated under Standard 2-20:

2-20 At a minimum, graduates must be competent in providing oral health care within the scope of dental therapy under the supervision of a licensed dentist, including:

- a. oral health instruction and disease prevention education, including nutritional counseling and dietary analysis
- b. comprehensive charting of the oral cavity
- c. making radiographs

d. dental prophylaxis

- e. dispensing and administering non-narcotic analgesics, anti-inflammatory, and antibiotic medications
- f. applying topical preventive or prophylactic agents (i.e. fluoride), including fluoride varnish, antimicrobial agents, and pit and fissure sealants.
- g. pulp vitality testing
- h. applying desensitizing medication or resin
- i. fabricating athletic mouthguards
- j. changing periodontal dressings
- k. administering local anesthetic
- I. extraction of erupted primary teeth
- m. emergency palliative treatment of dental pain limited to the procedures in this section
- n. preparation and placement of direct restoration in primary and permanent teeth
- fabrication and placement of single-tooth temporary crowns
- p. preparation and placement of preformed crowns
- q. indirect and direct pulp capping on permanent teeth
- r. indirect pulp capping on primary teeth
- s. suture removal
- t. replacing a fractured tooth on a removable prosthetics
- u. removal of space maintainers



Program Changes: Enrollment

The DA RC reviewed the revised Policy on Reporting Program Changes regarding changes in enrollment. They determined an additional policy concerning enrollment number changes would be redundant. The DA RC electeds to rescind its original proposal for a policy and guidelines for Authorized Enrollment.

Recommendation: It is recommended the Commission rescind its approval of the Winter 2013 DA RC recommendation to develop a Policy on Authorized Enrollment. The DA RC determined the existing policy on reporting program changes sufficiently addresses enrollment changes in dental assisting education

February 2013 Policy on Off-Campus Sites

The DA RC stated the February 2013 Policy on Off-Campus Sites would be burdensome to Commission volunteers responsible for reviewing lists of newly proposed dental office sites, bi-annually. The DA RC requests the Commission reinstate the following paragraph, removed in February 2013, in the Policy on Off-Campus Sites:

"The Commission recognizes that dental assisting and dental laboratory technology programs utilize numerous extramural dental offices and laboratories to provide students with clinical/laboratory practice experience. In this instance, the Commission will randomly select and visit several facilities during the site visit to a program."

The DH RC met on July 9-10, 2013 at ADA Headquarters.

Frequency of Citings at Site Visits

Standard 1 Institutional Effectiveness

58 citings, Standard 1-1 Program planning and assessments

Standard 2 Educational Program

411 citings, of which 104 were for Standard 2-16 regarding graduates' competency in providing dental hygiene care for various age groups. 89 citings for Standard 2-7 for written documentation of the curriculum provided to students at th initiation of course instruction.

Standard 3 Administration, Faculty, Staff

170 citings, 39 of which were for Standard 3-7 required educational methodology for faculty.

Standard 4 Educational Support System

89 citings

Standard 5 Health and Safety Provisions

48 citings, 38 of which were for Standard 5-1 Regulatory state, institute, program policies on infection control, hazards, with distribution to students, staff etc.

Standard 6 Patient Care Services


93 citings, 79 of which were for Standard 6-2 the program must have a plan for quality assurance for patient care.

Authorized Enrollment in Dental Hygiene

The DH RC reviewed 3 comments submitted and noted the recently revised Policy on Reporting Program Changes sufficiently addresses changes in DH enrollment indicating an additional policy would be redundant.

Recommendation: It is recommended the Commission rescind its approval of the Winter 2013 DH RC recommendation to develop a Policy on Authorized Enrollment. The DH RC determined the existing policy on reporting program changes sufficiently addresses enrollment changes in dental hygiene education.

DH Frequency of Citings Per Standard



Consideration of Accreditation of Master's Degree Level Dental Hygiene Programs

The DH RC reviewed 13 comments from the dental hygiene community, ADEA, ADHA and determined most master's degree programs are not clinical and focused on education, public health administration, research, and business disciplines. Most are housed within graduate schools granted graduate-level accreditation through regional accreditation agencies. The Commission accredits non-clinical disciplines such as Dental Public Health. The DH RC determined there is no need to accredit master's degree level dental hygiene programs at this time.

Recommendation: It is recommended the Commission on Dental Accreditation discontinue its feasibility study on the accreditation of master's degree dental hygiene programs, noting there does not appear to be a need to accredit these programs at this time.

Proposed Changes to Accreditation Standards: Due to matters of accreditation status and the Frequency of Citings, the DH RC recommended revisions to DH Standards 2-20 and 3-7.

Proposal to Form Subcommittee to Revise Support Documents

Multiple comments on Post Site Visit Surveys suggest the documents be revised, streamlined, consolidated, and exhibits more relevant. Two members of the DH RC have initiated the process of support document revisions with new exhibit documents. The DH RC recommends the formation of a two-person subcommittee to meet with CODA staff for one (1) day prior to the Winter 2014 Commission meetings to review the revisions and finalize the support documents.

Recommendation: It is recommended that the Commission appoint a subcommittee for the purposes of reviewing, revising, and finalizing dental hygiene accreditation support documents such as the self-study and related exhibits, site visitor evaluation report, and related site visit materials.
